### Do you know that you can Go Green with your EFT paystub?

The BESTNET Employee Self Service Site gives you direct access to your personal payroll data via the Web. You can review, print, or save your latest pay stub or annual W-2 tax form at your convenience from work or at home. Once you register, you must determine whether you wish to have your EFT Stub printed and delivered or mailed to you, or if you wish to NOT print the EFT Stub and access their Earnings information on ESS only. To register, visit the ESD website, click on Payroll and Benefits and then look for Payroll Self Service Site.

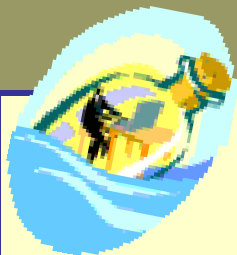

## Know Your Contract!



### Article XIV ~ Unit Member Evaluations

A program of regular, periodic evaluation involving all unit members shall be designed to achieve these purposes:

- (A) To identify standards and condition of professional service in ESD
- (B) To upgrade through professional counseling the job performance of all unit members
- (C) To provide a simple permanent record of the quality of each unit member's service.

#### Frequency of Evaluations

The performance of each certificated employee with permanent status shall be evaluated and assessed on a continuing basis as follows:

1. At least twice each school year for probationary and temporary personnel.
2. At least once every other year for personnel with permanent status

## Ed Code Briefs

With Flu season just around the corner, number of questions have been raised regarding the actions school districts may take in response to the spread of flu (specifically Swine Flu). This updated CTA advisory is intended to answer those questions per California Ed Code.

**Can schools be closed to contain swine flu?** Recently, the California Department of Public Health and the Centers for Disease Control and Prevention ("CDC") has revised its guidance, and now advises that school closure is not recommended "unless there is a magnitude of faculty or student absenteeism that interferes with the school's ability to function."

**If a school is closed, how long will the closure last?** The California Department of Public Health and the CDC initially recommended that schools that are closed resume their normal operations only after there were no confirmed cases of swine flu among staff or students for fourteen days time. As noted above, CDC no longer recommends school closures in response to swine flu except if student and/or staff absenteeism interferes with the school's ability to function.

**What happens to the school district's ADA funding if a school closes?** The Education Code contains a hold harmless provision specifying that in the event a school is closed due to an epidemic, or an emergency order by a federal, state, city or county official, the district is credited for the estimated ADA the school would have had if not for the epidemic or emergency order. Educ. Code Secs. 46390, 46392. The Code further specifies that a district that is unable to operate a full day school year due to an epidemic or an emergency order by a federal, state, county or city official, is to receive "the same apportionment from the State School Fund as it would have received" if it had operated for the full school year. Educ. Code Sec. 41422.

**Will schools that are closed have to make up the days at the end of the year?** The Education Code excuses districts from complying with the full school year requirements in the event of an epidemic or an order by a federal, state, city or county official in response to an emergency situation. Educ. Code Sec. 41422. See also Educ. Code Sec. 37202 (excusing such schools from the "equal time" requirement).

## IS FINANCIAL CLUTTER OVERWHELMING YOU?

**TAKE THESE SIMPLE STEPS TO GET ORGANIZED.**



How can you identify if you have financial clutter? Ask yourself these questions:

1. Do you have multiple bank accounts?
2. Do you have multiple credit cards?
3. Do you receive too many bank and other business type statements monthly?

If you answered "yes" to any of these questions, you may be suffering from financial clutter.

You can free yourself of financial clutter—similar to having a garage sale or donating unwanted items to charity—and gain a rewarding payoff. Your payoff can be lowering banking fees (and/or eliminating fees), reducing your exposure to identity theft, and saving time and the environment. Below are some simple steps to take to reduce your financial clutter.

1. **Identify the clutter** – make a list of all of your financial accounts, credit cards, and other assets and debts. This will show you what you own and what you owe, helping you figure out what you don't need.
2. **Consolidate bank accounts** – review your list of the accounts (see above); research which accounts offer the best services at the lowest cost and stop or transfer any automatic deposits or payments on the less attractive accounts, and instruct the financial institutions to close those accounts.
3. **Get rid of high-rate credit cards** – use only credit cards with a low interest rate and close other accounts to free yourself from paperwork, advertising catalogs and identity-theft risk.
4. **Shred bank statements and use online banking** – most banks and credit unions offer online banking, bill payment and eStatements at no cost. Not only is online banking environmentally-friendly, it also greatly reduces identity theft from occurring.
